Recreation fees are an investment in outdoor recreation. Current and future generations will benefit as 95% of the funds are reinvested locally in the facilities and services that visitors enjoy, use and value.

# Accomplishments provided with recreation fees on the Custer National Forest:

- Provided visitor information on recreational opportunities, outdoor safety, and natural resources.
- Funded employees who completed campground and cabin maintenance tasks, patrolled fee sites, and provided visitor information.
- Contracted for solid waste disposal and toilet pumping services across the forest.
- Administered, monitored and inspected outfitter and quide special use permits.
- Completed trail maintenance work and provided Wilderness patrols on trails used by outfitters and guides.

### **Special Feature**

Trail users benefit from the combined efforts of volunteers and Forest Service employees. Working together they cleared hundreds of windblown trees from trails on the Beartooth Ranger District. Hikers may not have recognized that only days earlier, their route was virtually blocked. Sometimes the best use of REA funds is not easily seen, but results in desired experiences.


