**TALLULAH RIVER CAMPING**

Pursuant to Title 36 C.F.R. Section 261.50 (a) and (b), the following prohibition apply to Tallulah River Road (FS #70) and all areas within 300 yards of the Tallulah River extending from the U.S. property line on the south side of FS #70 to the U.S. property line just north of Sandy Bottoms Campground except for the following developed campgrounds located on the Chattooga River Ranger District within the Chattahoochee National Forests: (1) Tallulah River Campground (2) Tate Branch Campground, (3) Sandy Bottoms Campground. This closure is effective on July 25, 2013 through July 25, 2023.

1. Camping. 36 CFR 261.58 (e)
2. Building, maintaining, attending, or using a fire campfire or stove fire. 36 CFR 261.52 (a)

Pursuant to 36 C.F.R, Section 261.50 (e), the following persons are exempt from this order:

1. Persons with a permit specially authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer or member of any organized rescue or firefighting force in the official performance of their duties.
3. Landowners or their tenants/agents or any person with written permission from the Forest Supervisor or District Ranger.

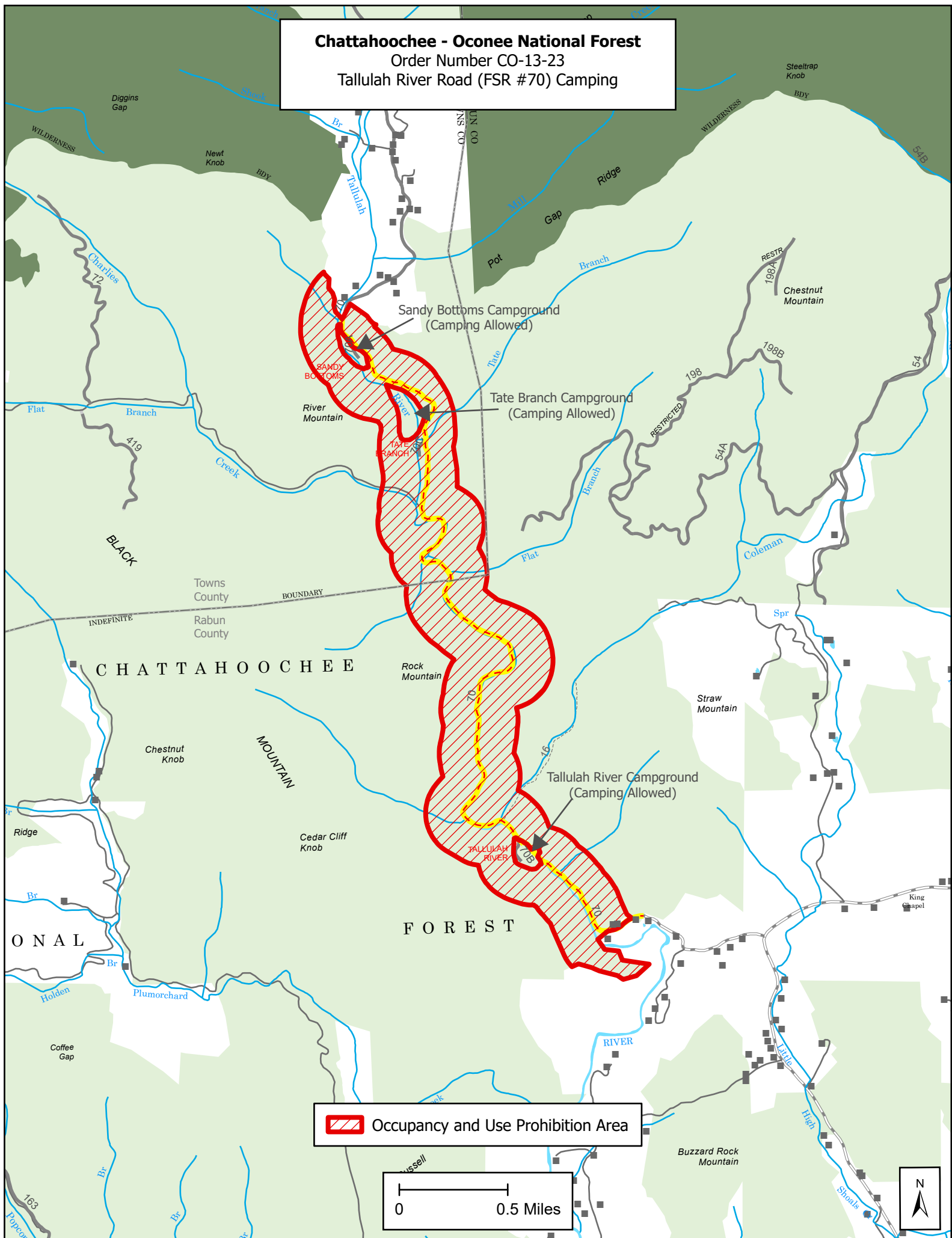

**To:** Forest Leadership Team, Frontliners, Law Enforcement and Public Affairs

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), for the protection of public health and safety, the following closure orders applicable to the Chattahoochee-Oconee National Forest are extended while undergoing analysis and review:

The original purpose and need for these closure orders have not changed, and no new conditions exist that fall outside the scope and range of effects in the original assessments.



These closures are effective from the original date signed by the Forest Supervisor until July 25, 2025, or until terminated by an authorized Forest Service official, whichever occurs first.
