SALT CREEK SUMMIT SNO-PARK



General Information: The Salt Creek Summit Sno-Park is located 20 miles southeast of Joseph, Oregon at the crest of Salt Creek and Little Sheep Creek. Numerous Nordic and snowmobile trails are accessible form this scenic location.

Restrictions: None on the trails.

- All wilderness areas are closed to snowmobiles and other motorized use.
- Please respect all posted private land in the area.

Access: From Interstate 84 turn east at La Grande, Oregon onto State Highway 82 and travel 67 miles to Joseph , Oregon . Turn left (east) on State Hwy. 350 (Imnaha Hwy) and travel approximately 8 miles to the Wallowa Mtn. Loop (FS 39 Rd) junction. Travel approximately 12 miles on the FS 39 Rd. until you reach Salt Cr. Sno-Park (end of plowed road).

Attractions: This sno-park provides access to over 175 miles of designated snowmobile trails and approximately 20 miles of cross-country ski trails. Seven loops of cross-country ski trails are rated from "Easy" to "Most Difficult". The snowmobile routes connect to the southend of the Wallowa Mountains (Whitman Ranger District; Pine Unit) via FS Road 39.

Considerations: Snowmobile routes are groomed and signed by the local snowmobile club, Wallowa County Gamblers, in agreement with the Forest Service. Nordic ski trails are marked but not groomed by the Nordic Ski Club and Forest Service. Please remember, grooming and trail conditions can change rapidly according to the weather.

Use: Moderate during the week; Heavy on weekends and holidays
