# Recreation Program









Recreation fees are an investment in outdoor recreation. Current and future generations will benefit as 95% of the funds are reinvested in the facilities and services that visitors enjoy, use, and value.

## Accomplishments Provided with Recreation Fees on the Lolo National Forest:

- Completed maintenance and operations tasks, replaced picnic tables and fire rings, and funded employees who provided visitor information and compliance checks at cabins, campgrounds, boat ramps, and picnic area.
- Completed renovations at Double Arrow Lookout and made it available for public rental.
- Processed and administered outfitter and guide and recreation event special use permits. Recreation events included trail runs, mountain bike races, dogsledding and cross country ski events, off-highway vehicle rides, and snowmobile runs.

#### **Special Feature**

The Double Arrow Lookout opened to the public in 2011 after volunteer groups, funded through recreation fee revenue, rehabilitated the lookout. Built in the 1930s, the lookout tower provides inspiring views of Seeley Valley and the Swan Mountain Range. Visitors also have easy access to a variety of nearby hiking trails and water activities at Seeley Lake.
