STEWARDSHIP ACCOMPLISHMENTS 2013



WILDLIFE

Wildlife habitat:

- 4,478 acres improved
- Monitored one peregrine falcon site
- 10.7 kilometers of harlequin duck surveys.
- Wildlife information shared with approximately 17,309 individuals at public events: Cabela's Spring and Fall Great Outdoor Days, Stillaguamish Festival of the River, Sauk-Suiattle Pow-wow, Rockin' the Wild, Eagle Watchers, Migratory Bird Festival, Horizon Elementary, Bat Event at Gold Creek.

WATER

Watershed rehabilitation: 1,381 acres of water or soil resources protected, maintained or improved to achieve desired watershed conditions.

FISHERIES

Fish habitat protection: 30.4 miles of anadromous and resident fish habitat protected by riparian planting, road upgrades and road storage.

BOTANY

Noxious weed treatment: 1,035.6 acres **Volunteers contributions:** 964 hours controlling, surveying, mapping noxious weed infestations and conducting site restoration.

Rare Plant Conservation and Monitoring:

MBS continued our partnership with University of Washington's RareCare program. Thanks to their excellent work we were able to accomplish monitoring of arctic aster, boreal bog sedge, stalked moonwort, and small northern bog orchid. The N Zone botanist monitored boreal jewelweed, black lily, goblin's gold moss, round-leaved orchid, and Rainier speckleberry lichen (Pseudocyphellaria rainierensis).
