INTRODUCTION

CHANGES / REPAIRS

• Fixed a problem where tally counts would become corrupted after a Pocket PC went through a suspend/resume cycle and tallying was continued.

KNOWN BUGS AND CAUTIONS

All:

- There can be a noticeable delay when data is saved. An hourglass will now appear when data is saved during tallying. Consider decreasing the frequency of saves by increasing the *Save data every n tallies* value in the Setup dialog. The delay will depend on data recorder speed. Experiment to see which save frequency works best for you.
- Watch what you're doing when copying and pasting cruise data files: If you have multiple tally files with the same name (like you would when making backup copies) be careful not to overwrite a newer file with an older one. If you accidentally do this there is no going back.

PC

• Never open a tally file residing on a server, even via a mapped drive (e.g. J, K or L). Copy it from the server to a local directory on your PC first.

PLANNED ADDITIONS AND IMPROVEMENTS

- Present data in a grid (table) rather than a forms-based dialog. This will allow nearly unlimited data fields.
- Add 3P sampling.
- Improve the speed of program execution (which affects how fast you can tally).
