Dear Judge Strother:

This letter is in response to the Request for Comments regarding Bell Timber's application to the U.S. Department of Agriculture for a Sourcing Area for its Longview and Bellingham, Washington facilities.

Vaagen Brothers Lumber has mills in Colville and Usk, Washington. We directly employ more than 250 people and rely on federal, state and private timber to keep our mills running and our employees working. In addition to our sawmills, four other mills work in the same wood basket and the log supply is tight. We have sold logs to Bell Timber from our federal and state timber sales in the past, and plan to continue to do so in the future. If Bell Timber were granted a Sourcing Area, it would further constrict the supply of logs to mills in northeast Washington, endangering their viability and putting the people and communities that rely on them at risk. We respectfully request that you decline Bell Timber's application for a sourcing area.




