THE FOREST HERITAGE NATIONAL SCENIC BYWAY

Some sites reservable (with service fee) at Davidson River, Lake Powhatan, and North Mills River four to 240 days in advance: (877) 444-6777; TDD: (877) 833-6777); or <u>www.recreation.gov</u>. Maximum stay for all campgrounds is 14 days at one time; 30 days total between Memorial Day and Labor Day. Firewood is available at Davidson River and Lake Powhatan. ^{*}Riverside sites. ¹In winter: no water; vault toilet only; fee, \$11.00. **Showers <u>NOT</u> available during winter season.

PRIMITIVE AND ROADSIDE CAMPING

Primitive camping is allowed at least $\frac{1}{4}$ mile away from any road open to traffic and outside of any developed recreation sites. Roadside camping is allowed ONLY along gravel roads where designated by this sign: In all cases, vehicles **MUST** remain on the road shoulder in widened pull-outs, where they won't interfere with traffic, or damage vegetation. No trash pick up is provided, so be sure to "*Pack it in - Pack it out.*" It is **MANDATORY** to bury all human waste and toilet paper away from streams. Be sure to clean up before leaving. **NO FIREWOOD CUTTING** except for dead and downed wood. Maximum stay: 14 days in one location.

E FOREST DISCOVERY CENTER CRADLE OF FORESTRY IN AMERICA HISTORIC SITE

The site of the first forestry school in America is located 9.5 miles north of ranger station on US 276. **Highlights:** hands-on exhibits, gift shop, cafe, guided walks on 3 paved trails with historic buildings, restored portable sawmill, and logging locomotive. Open 9 a.m. to 5 p.m. mid-April through mid-November. Fee: Adults \$6; Children 4-12 \$3. Groups should call (828) 877-3130 for information.

No boats, canoes, or watercraft of any kind are allowed on Lake Powhatan. A lifeguard is on duty Memorial Day weekend (end of May) through Labor Day, 8 AM to sunset, unless posted otherwise. *Seasonal pass available at site; also covers day use at North Mills River Recreation Area.

*Sliding Rock: A site manager is on duty 10:00 a.m. to 6 p.m. Memorial Day weekend through mid-August. Weekend staffing is possible into mid- October. At other times, restrooms are closed, and no fee is charged. NO PICNICKING & NO ALCOHOL are permitted.



Approximately 380 miles of maintained recreation trails in the district offer a wide variety of length, difficulty, and terrain, with many trails open to horses and non-motorized mountain bikes. (Some bike trails are seasonal.). On all trails, always pack out trash, and please practice other "Leave No Trace" land ethics. Maps are available at the Pisgah Visitor Center; by mail order at The Forest Place, (800) 660-0671ext.228; or online at www.theforestplace.com.

Shining Rock and Middle Prong Wilderness Areas offer a primitive experience for hiking and backpacking. *Trails are not* signed or blazed, so map and compass use are essential. To maintain wilderness quality, no more than 10 people per group are allowed. NO CAMPFIRES are permitted and mountain bikes or wheeled carts may not be used. No permit is required.

FOREST SERVICE (FS) ROADS

Most Forest Service roads are gravel-surfaced and open to the public. Some roads are gated and, unless signed otherwise, are available for use by foot, bike, and horse traffic. When parking along forest roads, use the widened pull-outs or park well over on the road shoulder. This prevents interference with road traffic or gates blockage.
