We are providing public notice of an administrative change to the 2004 Chequamegon-Nicolet National Forest Land and Resource Management Plan (Forest Plan). The purposes for making administrative changes to a land and resources management plan include corrections of clerical errors to any part of the plan, conformance of the plan to new statutory or regulatory requirements or a change to other content in the plan (§219.7(f)). Administrative changes require public notification (§219.16(c)(6)). Administrative changes are not subject to an objection process (36 CFR 219.50).

The purpose of the enclosed administrative change is to add and divest lands exchanged with the State of Wisconsin Board of Commissioners of Public Lands (BCPL). An exchange agreement was signed on December 13, 2021. Compliance with the National Environmental Policy Act (NEPA) was accomplished and approved on August 31, 2021. This administrative change will also assign management areas and management area direction to the lands acquired by the Forest Service.

We determined the enclosed land acquisitions, management area designations, and assigned management direction meet the requirements of an administrative change as defined at §219.13(c). In accordance with §219.13(c)(2) and Forest Service Policy (Forest Service Handbook 1909.12, Chapter 20, paragraph 21.5), this administrative change is effective immediately after publication of this notice on the Chequamegon-Nicolet National Forest website at: Chequamegon-Nicolet National Forest - Home (usda.gov).

Administrative Change to the 2004 Chequamegon-Nicolet National Forest's Land and Resources Management Plan – 2021 BCPL Land Exchange

Subject

Administrative Change for adding and divesting lands exchanged with the State of Wisconsin Board of Commissioners of Public Lands (BCPL)

Background

On August 31, 2021, the Forest Supervisor of the Chequamegon-Nicolet National Forest published a decision letter regarding a land exchange between the Forest Service and the State of Wisconsin Board of Commissioners for Public Land. The final land exchange agreement between the State of Wisconsin and the USDA Forest Service was signed on December 13, 2021.

Purpose

The purpose of this administrative change is to add 4,349.58 acres of exchanged lands to the Chequamegon-Nicolet National Forest by updating Geospatial Information System (GIS) boundary and management area layers and by assigning Forest Plan management area direction.

A second purpose of this administrative change is to account for 3,338.48 acres of divested federal lands owned and managed by the State of Wisconsin.

Process

The process for adding acquired lands and disposing of lands from the BCPL land exchange is consistent with the guidelines for Surface and Ownership and Land adjustments in chapter 2 of the 2004 Forest Plan on pages 2-33 and 2-34. Management area assignments are consistent with procedures for assigning management area prescriptions for newly acquired national forest system land on page 2-34 of the Forest Plan.

Changes

The following tables include a list of acquired lands with management area assignments. In chapter three, the 2004 Forest Plan includes plan component direction for each management area. Other necessary management direction being assigned to each management area such as the recreation opportunity spectrum and scenic integrity objectives is available in the 2004 Forest Plan and its associated maps for the FEIS selected alternative.




