Subject: Survey and Manage Project Exemptions - Northwest Ecosystem Alliance, et al. v.

Mark E. Rey, et al., No. C04-844P (W.D.Wash)

**Program Area:** Survey and Manage Program.

**Purpose:** To distribute the October 11, 2006, Order by the District Court, in the above referenced case, amending the January 9, 2006, injunction which reinistated the January 2001 *Record of Decision and Standards and Guidelines for Amendments to the Survey and Manage, Protection Buffer and other Mitigation Measure Standards and Guidelines*, including amendments or modifications to the 2001 Record of Decision in effect as of March 21, 2004.

**Policy/Action:** The January 2006 Order conditionally halted all logging or other habitat disturbing activities that required Survey and Manage related surveys (as per the 2001 Record of Decision). The October 2006 modification allows four categories of activities to proceed without performing pre-disturbance Survey and Manage related surveys. These project categories are as follows with further description in the attached Order:

- 1. thinnings in forest stands younger than 80 years of age,
- 2. culvert replacement/removal,
- 3. riparian and stream improvement projects, and
- 4. hazardous fuel treatments which apply prescribed fire.

Districts and Field Offices are directed to review projects for which an exemption might apply and summarize the project type and rationale for application of the exemption. Document the deciding official's determination that the project meets the exemption in either the environmental analysis or project decision document, as appropriate. This documentation should ensure project decisions are in compliance with the District Court ruling as stated on page 1 of the October 11, 2006, Order in Northwest Ecosystem Alliance et al. v. Rey et al.

**Timeframe:** This District Court Order was effective as of October 11, 2006.

**Budget Impact:** N/A

**Background:** The October 2006 Order is the result of discussions between the Plaintiffs (Northwest Ecosystem Alliance, Gifford Pinchot Task Force, Environmental Protection Information Center, Klamath Forest Alliance, Umpqua Watershed, Inc., Siskiyou Regional Education Project, Klamath-Siskiyou Wildlands Center, Oregon Natural Resource Council Fund, American Lands Alliance, Center of Biological Diversity, and Northcoast Environmental Center) and the Defendant-Intervenors (Douglas Timber Operators, Inc., and American Forest Resource Council).
