Statement of Work
As directed by and in coordination with FEMA, US Forest Service (USFS) will pre-position wildland firefighter handcrews (or equivalent configuration) with the equipment necessary to clear fallen trees, brush, and debris from roads to facilitate emergency access in disaster area in support of FEMA disaster operations. This includes pre-positioning an incident management team to coordinate and support road clearing activities.

Additional Statement of Work

If authorized by FEMA, USFS will establish a Base Camp to provide lodging, meals, and support for firefighting and command/control personnel and equipment. This will be provided in lieu of per diem and under a separate mission assignment. USFS will utilize USFS, other Federal agency, and State/local resources under existing agreement, as appropriate. USFS is responsible for providing personnel and/or equipment necessary to accomplish the mission. - MA task orders (MATOs) may be issued by FEMA for specific requirements, personnel, location(s), date(s), and duration of assignment(s). - Agencies will be reimbursed for all eligible expenses pursuant to 44 CFR. Supporting documentation is required for reimbursement. - All equipment and supply purchases must be coordinated with FEMA Project Manager. If approved, documentation is necessary to ensure reimbursement. - Activation of agency command center(s), if required, must be coordinated with FEMA as a separate MA. - The mission-assigned agency is responsible for ensuring that all activity is properly authorized, goods are received, services are provided, and that costs are reasonable and supported by documentation maintained by the respective agency - MAs shall be considered for closure after 180 days with no financial activity in accordance with FEMA CFO Bulletin #157.
