ESF4 at the time of reply are as follows: 1 ICT3,1 LSC2, PIOF. An additional position of FSC3 is available in a virtual capacity if requested. ESF4 will continue to pursue additional resources to fulfill this request. Resources are available for a 14 day assignment. Additional needs can be discussed after the first 14 day assignment. Resources will be based out of Wisconsin state fairgrounds, any changes in location will be negotiated with ESF 4 prior to change. Cost estimate is for a full Type 3 team to reflect additional resources that may be added added to the MA by ESF 9 or ESF 4.

- USFS will utilize other Federal agency and State/local resources under existing agreement, as appropriate.

- USFS will pre-position resources and/or provide assistance.
 USFS is responsible for providing personnel and/or equipment necessary to accomplish the mission. If authorized by FEMA, USFS will establish a Base Camp to provide lodging, meals, and support for firefighting and command/control personnel and equipment. This will be provided in lieu of per diem and under a separate mission assignment.
