## Fiscal Year 2023 Forest Service Legacy Reprogramming Request

Per the reprogramming guidance contained in the Joint Explanatory Statement, Division G, that accompanied the Consolidated Appropriations Act, 2023 (Public Law 117-328), the U.S. Department of Agriculture's Forest Service requests approval to reprogram \$18,174,000 in recovered balances from completed or failed Forest Legacy projects. In fiscal year (FY) 2021, a reprogramming of \$25,215,000 of recovered funds was approved to fund seven projects in seven states. A reprogramming request submitted in FY 2022 was not approved.

The recovered funds will provide grants to five states to acquire five high priority Forest Legacy lands. These five projects were reviewed and ranked using a competitive process but fell outside of available funds in FY 2023. The FY 2023 project list included 22 projects of which 14 projects were fully funded. Project number 15, Maunawili Valley, was partially funded.

Reprogrammed funds would be used to complete funding for the Maunawili Valley Project and fund the next four projects on the priority list (Table 2). These acquisitions will provide important public benefits such as protecting sensitive habitats and watersheds, conserving important cultural resources, and supporting rural communities that rely on resource management and recreation. Several of these acquisitions will provide new recreation opportunities for the public, including increased access to public lands.

Table 1 shows the balances from 11 projects funded between FY 2014 and FY 2020 that were recovered. These recovered funds will be used to complete additional Forest Legacy projects on the FY 2023 project list (Table 2).

Approximately \$5 million of the recovered funds are from two projects where the landowners chose not to proceed with the project, and instead, sold the properties to interested parties who offered a higher asking price or were able to move more quickly than the state. An additional \$5 million is from a project (LA-Clear Creek) funded over two years where the state ran into numerous challenges and ultimately chose to withdraw the project and return the grant funds. Just over \$1 million is four (4) years of administrative funds that states returned from administrative grants. The remaining approximately \$7 million is from transactions where the cost of the project was less than anticipated or where the entirety of the anticipated project could not be secured.

The Forest Service appreciates the continued support of Congress for the Forest Legacy Program and looks forward to hearing the Committee's decision.
