Seed procured from 2011 yields:

1600 lbs. *Elymus glaucus* (blue wildrye) - Westside high

1662 lbs. *Elymus glaucus* (blue wildrye) - Westside low

24 lbs. Lupinus latifolius (Broadleaf lupine) - Eastside

New Funds Obligated and Fields Planted:

450 lbs. *Elymus glaucus* (blue wildrye) - Eastside high 350 lbs. *Elymus glaucus* (blue wildrye) - Eastside low

Restoration Project Implementation:

Approximately 100 miles of decommissioned roads were seeded with blue wildrye and California brome.

Numerous disturbed sites (mostly less than one acre) were seeded with blue wildrye, California brome, and/or staked with riparian cuttings (red-osier dogwood and willows) – including at roadsides, timber sale areas, ski resorts areas, dispersed campsites, and decommissioned stream crossings.

Hardwood Cuttings Propagation:

We collected black cottonwood foundation cuttings for propagation at Clarno hardwood production beds in cooperation with Bend Ft. Rock Ranger District, Deschutes National Forest.

Funds were also used to clean and store native seed, and for salaries to: collect native plant materials, develop and administer contracts, update native plant material tracking system, and implement revegetation efforts.
