2014 Invasive Species Accomplishments

Control emphasized garlic mustard, Japanese barberry, exotic honeysuckles, glossy buckthorn, Eurasian watermilfoil, purple loosestrife, and Japanese knotweed. Work was accomplished by a seasonal crew, partners, contractors, and volunteers. 55 new invasive plant sites were mapped.

Great Lakes Restoration Initiative projects:

- Provided coordinators for two Cooperative Weed Management Areas (WePIC and KISMA).
- Six portable pressure washers staffed at boat launches across the Western Upper Peninsula.
 8,097 people received Clean Boats/Clean Waters education for prevention of aquatic invasive species; 1,021 boats washed.
- New boater education and boat washing agreement with the Keweenaw Bay Indian Community.
- Funding for Wildlife Forever Stop Aquatic Hitchhikers billboards campaign in Michigan.
- Funded new "Lake Hoppers" education campaign by ISCCW.
- Contracted surveys in 27 lakes for AIS.

Title II Resource Advisory Committees (RAC):

Funded five ongoing invasive plant projects:

- The Friends of Sylvania again hired their own seasonal employees to survey and control invasive plants in Sylvania Wilderness.
- The Gogebic Conservation District managed garlic mustard
- The Langford Lake Association managed Eurasian watermilfoil in Langford Lake.
- The Lake Gogebic Improvement Association worked with Whitewater Associates to manage aquatic plants in Lake Gogebic.
- The USFS awarded a contract for management of Japanese knotweed in Ontonagon County.

Stewardship Contracting:

Clean Kill Invasives continued working on a large honeysuckle infestation in Gogebic County, funded by retained receipts.
